

The Job is to Help People

The guiding principle at Makarem & Associates is to care, and right wrongs.

After founding the Los Angeles law firm Makarem & Associates in 2004, Ron Makarem's initial case involved a future president. He represented Mark Bethea, a writer who sued Donald Trump, NBC, and producer Mark Burnett of "The Apprentice," alleging his idea for a reality television show had been stolen.

Makarem recalls visiting Trump Tower for the deposition, where he encountered a "very relaxed, narcissistic" Trump, he said. "At the time, we didn't really know that much about him other than what we saw on TV, but nothing's changed. He's the exact same person."

gent burden of proof, he noted. Instead, his firm, with a team of 10 attorneys in Brentwood, has turned its focus to legal malpractice, employment law and discrimination, wrongful termination, wage and hour claims and sexual harassment cases.

Regarding legal malpractice cases, Makarem said, "I'm proud of that area of law that we do, and I think it's a really necessary part of our profession. The State Bar just doesn't have the resources, and I think lawyers in general are proud of the work we do, because it keeps our profession with a high integrity level."

One of his biggest cases occurred in 2006, when Makarem represented an ophthalmologist, Dr. Morry Waksberg, ultimately

gal malpractice case that made it to the California Supreme Court, Makarem argued a significant case related to the mediation privilege, in which the judge ruled that mediation discussions between lawyers and clients must remain confidential.

Samuel D. Almon, a partner at the firm, also emphasized the importance of class actions or collective actions on behalf of employees, describing the firm's clients as "individuals who have been discriminated against or wrongfully terminated, sometimes based on pregnancy or race or sex."

"We've had cases against some really big national companies — Tesla, Facebook, Walmart, Starbucks — and we're a small firm," Almon said. "But one of the things that makes me proud of our firm and our culture is that we're not afraid to go up against those big companies, who typically are defended by a national law firm. But by the same token, if we see that there's been a clear wrong committed, we will take cases against smaller companies as well. ... We're motivated by helping these clients, who are not coming from a position of power ... and so it's very gratifying to be able to help them."

Matthew J. Matern, a Manhattan Beach attorney who was co-counsel in the case against Skadden Arps, said he admires the small firm and its leadership.

"I think Ron has assembled a

great team of attorneys," he said, "and he's a great leader in terms of leading by example. ... Ron has always been an excellent litigator. I think he has great instincts for litigating cases and getting his clients excellent recoveries because of his skillful use of litigation to their benefit."

Makarem's leadership is motivated by a "desire to care for people and help people," he said. "When they go through a hardship I care about when they've been wronged, and I want to right it. ... That has motivated me not only to be a good lawyer myself but to inspire the people around me, and the team

has fed off that. I think they've really taken that as our mission, to empower people when they're down. ... If nothing else, what I want to get out there is that it's our job as lawyers and my job as a person just to care about people and help them when they need it most. ... That's our guiding principle."
